EFSPI Regulatory Statistics Workshop

The EFSPI Regulatory Statistics Workshop took place on the 12-13th October 2020 14:00-16:35 (CEST). The topics for each webinar were:

Webinar 1: Data monitoring committees – evolving their role in a changing drug development landscape

Webinar 2: Estimands – emerging questions now that we are using the framework

Meetings with Regulatory Statisticians

On October 2nd EMA's Biostatistics Working Party (BSWP) held a virtual stakeholder meeting with several industry trade organizations and EFSPI. Topics were the BSWP's guidance on COVID-19 implications to statistics and their draft guidance on quality attributes in CMC. Dan Evans and Bruno Boulanger presented on behalf of EFSPI. Estimands in Oncology ESIG

The oncology estimand SIG held / will hold informal TCs with the Health Authorities of the US FDA, HC + Swissmedic, MHRA, Japan, China, and Taiwan. In these TCs the WG presented a summary of the

work that has been done in the last two years and invited HAs to comment and raise points they encourage the WG to look into or where they could imagine a collaboration. Generally, these HAs very much appreciated the informal information sharing and encouraged the WG to continue its work and the interactions with authorities. 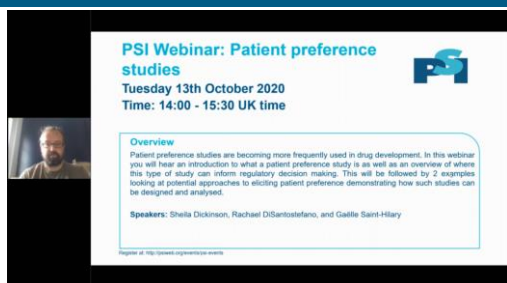

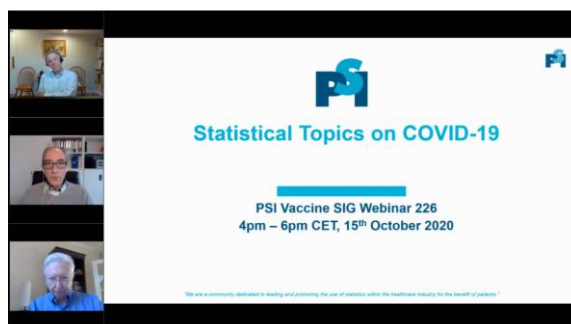
